
ATTORNEY GRIEVANCE COMMITTEES FOR THE FOURTH JUDICIAL DEPARTMENT, PETITIONER.

Petitioner having applied to this Court for an order directing certain attorneys, each of whom is named on the list attached hereto, to show cause why they should not be suspended from the practice of law on the ground that they have violated Judiciary Law § 468-a and 22 NYCRR 118.1 by failing to comply with attorney registration requirements,

NOW, upon reading and filing the affidavit of Cydney A. Kelly, sworn to March 25, 2022, the statements of Cydney A. Kelly, dated March 30 and April 4, 2022, and due deliberation having been had thereon,

It is hereby ORDERED that each of the respondents named on the attached list is directed to show cause before this Court on or before August 1, 2022, by filing with this Court a written response to this order together with proof of service on counsel for petitioner, why an order should not be entered suspending the respondent from the practice of law for failing to comply with attorney registration requirements, and,

It is further ORDERED that, pursuant to Judiciary Law § 90 (6), petitioner is authorized to serve each of the named respondents with this order by: mailing a certified copy of this order to the respondent at the address that the respondent has provided to the Office of Court Administration; publishing a certified copy of this order in the New York Law Journal once each week for four consecutive weeks, commencing with the week of May 16, 2022, and ending with the week of June 6, 2022; and, posting a certified copy of this order on the website maintained by this Court for a minimum of thirty (30) days, commencing May 16, 2022.
